## Assisted Suicide Bill Gets Hearing!

HB 675 (titled death with dignity), which would legalize physician assisted suicide, has been scheduled for hearing by the House Health Committee.

**February 7, 2007 (Wednesday)  
5:00 p.m. (Auditorium in the State Capitol)**

We ask that you:

1. **Submit testimony.** Testimony may be faxed if less than 5 pages in length to the HOUSE SGT.-AT-ARMS OFFICE AT: 586-6501 (OAHU) OR 1-800-535-3859 (NEIGHBOR ISLANDS). When faxing, please indicate to whom the testimony is being submitted (House Health Committee), the date and time of the hearing (noted above) , and the required number of copies that is needed for submittal (20 copies). Testimonies submitted after 3:00 p.m. on the day before the hearing will be considered late testimonies, but it is okay to send it in. [\(Click here for talking points\)](#)
