Homeless Services Bill Needs Your Kokua

There is only one more day before conference committee members finalize the budget concerning homeless services.

Homeless services providers, such as Catholic Charities, are concerned that instead of the \$13 million dollars the Governor proposed for homeless services, only \$8.78 million will go into homeless services. This means that many programs may not get funded or will be under funded.

Considering we have a homeless crisis impacting families and children, Hawaii's most vulnerable need the money allocated by the Governor.
